## **MEMBERSHIP RULES AND REGULATIONS**

#### **Membership Categories**

NEGGC offers two categories of Associate Membership:

- Individual Membership
- Corporate Membership

#### **Individual Membership**

- Individual Membership is for individuals, their spouses, and dependent children- sons up to 25 years of age and unmarried daughters up to 35 years of age.
- · Individual Membership can only be transferred by the primary member in accordance with the rules, regulations, and transfer fees as determined by the management from time to time.

#### **Corporate Membership**

- · Corporate Membership is intended for firms, limited companies, corporate institutions, and societies.
- Under Corporate Membership, three nominees will be permitted to use the NEGGC facilities. Additional nominees may be added based on the terms and conditions.
- · Nominees can be appointed or changed only with the authorization of the corporate's authorized signatories.
- Corporate Nominees may use the facilities as per the rules and regulations of NEGGC.

#### **Membership Fees**

- Membership fees for each category will be determined periodically by the NEGGC management.
- · Membership fees within any category are non-refundable.

#### **Termination of Membership**

• The management reserves the right to remove any member from membership for misconduct, nonpayment of dues or annual maintenance fees, misbehavior, or violation of any rules and regulations of NEGGC.

#### **Affiliated Clubs**

- All members must settle their bills directly on a cash basis with respective affiliated clubs during their visits.
- Facilities of affiliated clubs are available to members subject to the rules and regulations of the respective affiliated clubs.

#### **Non-Payment of Dues**

 In all categories of NEGGC memberships, if the prevailing annual maintenance charges or any other dues payable towards membership of NEGGC remain unpaid for three years, the membership will automatically be canceled.

### **Payment of Dues**

- Dues, including the Annual Subscription or any other charges, must be paid by members on or before the due date as mentioned in the monthly invoice.
- Any unpaid dues beyond the due date will incur penal interest as decided by the management. If the amount of unpaid dues, including penal interest, exceeds the limit set by the management, NEGGC will block access to all facilities until all dues, along with penalties, are paid.

#### **Modifications**

• These rules and regulations are subject to modification as deemed necessary by the management.

### **Usage Rights**

• NEGGC membership grants the right to use the facilities of NEGGC Goa. It does not confer any rights or obligations regarding the title or interest in the ownership or management of NEGGC.

### **Guest Policy**

- A member or their spouse may bring guests to the NEGGC premises. The introducing member is responsible for ensuring that their guests strictly observe the NEGGC Rules, Regulations, and By-Laws.
- · Guests can be entertained on written request of the member to have accommodation and avail amenities and facilities.

#### **Membership Card**

- Each member will be issued a Membership Card based on the type of Membership applied for, which remains the property of NEGGC. The card must be returned upon the termination, discontinuation, transfer, or cancellation of the Membership.
- The membership card must be produced for inspection or verification at all times upon request by any official, employee, or duly authorized agent of NEGGC.

### **Annual Maintenance Fees and Facility Charges**

• NEGGC management reserves the right to determine the annual maintenance fees and charges for various facilities and activities, or to revise them without prior notice. The management also reserves the right to introduce additional facilities at its discretion.

#### **Membership Approval**

NEGGC Management may accept or reject any membership application without assigning any reason.

#### **Member Conduct**

 Members are expected to maintain proper decorum and dignity and must not cause harm or inconvenience to other members, guests, management staff, or property of NEGGC. Any behavior that is against the law will result in the immediate cancellation of membership by the management.

### **Right of Admission**

The right of admission is reserved with the NEGGC management.

#### Jurisdiction

• All matters pertaining to membership, use of facilities, and any disputes arising from the rules and regulations of NEGGC shall be governed by and interpreted in accordance with the laws of the state of Goa. Any legal proceedings or actions related to these matters shall fall under the exclusive jurisdiction of the courts located in Goa.
